Campaign school attracts 70

Representatives of progressive municipal campaigns throughout Metro Toronto met at the 519 Church Street Community Centre on the evening of August 2 to discuss strategy for the November 13 municipal election.

Approximately 70 candidates, campaign managers and organizers from campaigns which are either endorsed by ReforMetro or seeking the movement's endorsation, discussed general strategy as well as 'nuts and bolts' campaign techniques.

Discussion centred around the release of an extensively researched and comprehensive document, entitled "How to Run a Municipal Election Campaign and Win", which was researched and edited by Susan Sparrow.

The broadly based nature of the meeting with so many campaigns represented is just another of the many signs of the unity which exists among the reform movement in Metro and bodes well for the success of progressive campaigns in the November election.

More Candidate Schools will be held to instruct

campaign committee members in a more detailed way. Watch for them.

24 candidates endorsed

At the 2nd Delegate Assembly to endorse aldermen and trustee candidates for the November 13 municipal election, ReforMetro members approved 16 people (8 trustees and 8 aldermen) and referred two candidates to the August 15 Assembly.

This brings the total of endorsed candidates to 16 aldermen and 8 trustees.

ReforMetro has taken on an immense responsibility. in electoral organizing in Metro Toronto.

Endorsement of candidates is only the tip of the iceberg. We are committed to giving support of various kinds to them, mostly around campaign organization.

ReforMetro held its first candidate school on August 2nd and will be holding another towards the end of August (tentatively Tues. August 22 at 7pm, 519 Church Street). If required, a third school

SCANDAL!

Police investigations into the case of the missing building department files continue at Toronto City Hall.

A scandal erupted in late July over missing files concerning the illegal conversion of a Keele St. apartment house to bachelorettes.

Mayor David Crombie finally called in police to investigate after receiving approval from the City Executive Committee.

Crombie became aware of the disappearance six weeks earlier when city solicitor William Callow submitted a report, June 12.

The report noted the absence of important documents and inspector's field notes from department files, concerning the illegal building conversion at 410 Keele St.

Ib Amonsen, president of the Eloor-High Park Residents' Association submitted a report in March containing allegations

Stephenson: Injury to Labour

On May 29, six injured workers and one case worker were arrested at the Ministry of Labour during a demonstration of the Union of Injured Workers.

This demonstration was calling for changes in the Workmens Compensation Act. Nine days later, the Union's provincial president was charged as a result of the demonstration.

The Minister of Labour Dr. Bette Stephenson, finally responded in the provincial legislature by proposing the first changes to the Workmens Compensation Act in three-and-onehalf years.

It is unfortunate that injured workers had to be beaten and arrested to effect changes in the Act. However, this is the reality of conditions in Ontario

today.

The arrest of the eight members of the Union is of concern to all people of Ontario. It is another example of the present provincial government's attempt to stifle the legitimate protest of the people who have been unjustly treated by current government policy.

The UIW has established a defence committee at 37 Madison Avenue and asks for your support, both with donation to help pay for the legal defence and with your attendance at the trials which will begin on Sept.21 at Old City Hall, Court Room #31 at 10 am. The second trial will be on Sept. 26 in the same courtroom at the same time. All the others will be in November.

concerning the Keele St. building, a Globe and Mail report said.

Shortly afterward, Callow discovered that the relevant files were missing.

Amonsen said in a Toronto Sun report, "It reeks of corruption and I won't rest until the whole thing is out in the open."

Ward 2 Aldermanic candidate Barbara Adams said: "The implications are there that some politicians are on the take in some of these illegal conversions but it's hard to say to what extent."

Adams heads a working group on bachelorettes which pressures City Hall to take action against illegal building conversions.

David White, junior alderman for Ward 1, said


"Bachelorettes are very substandard forms of accommodation in terms of space and expense," White

In the Keele Street case. the former 24-room Junction Hotel, which once rented for \$1,25 per night, is now a 45-unit building renting for \$45 to \$60 per week.

TTC TRANSFER TRAGEDY NO. 1

Reformetro began a major campaign to "Reform the TTC" through a six part transfer message drop.

10,000 transfers were distributed at 10 subway stations during late July entitled Transit Tragedy No. 1.

The transfer format is attractive to TTC riders and the messages on all six transfers are eyecatching.

Transfer Tragedy No. 2 will be dropped near subway stations in mid-August.

WHEN DISTRIBUTING TRANSFERS KNOW YOUR RIGHTS...

You cannot hand out leaflets on TTC property but you can stand outside stations. You have every right to hand leaflets to people as long as you don't stand in their way and prevent them from passing.

The TTC has security guards who will try to get you to stop distributing information about the TTC which is politically embarrassing to management.

Here's one example of this from Ann Coops...

Gordon Hurlburt Chairman TTC 1900 Yonge Street July 28,1978 Dear Mr. Hurlburt:

"The following incident occurred on July 27 outside the entrance to the subway at the south-east corner of Yonge and Queen Sts.

While I was handing out information leaflets for ReforMetro regarding TTC fare increases, two TTC security workers approached me and identified themselves by quickly showing their identification. They asked whether I knew that I had one foot on TTC property and I responded by saying that I was unaware of this and moved my foot. They then proceeded to tell me that if I did not move from where I was standing, they would call the police because I was violating the Criminal Code by impeding traffic. I then stated that I was not impeding traffic in any way and that no individuals receiving the leaflets complained about this.

I suggested to these persons that their actions

Did your Metro Rep vote for you or against you? were in response to the political nature of the leaflets. To this, they indicated agreement and again stated that I was violating the Criminal Code.

Following this incident I investigated the matter personally. My actions were in no way contrary to the Criminal Code. Furthermore, the Chief of Police has stated, in relation to a similar incident, that leafletting near TTC property is not a violation of the Criminal Code.

My impression of this incident leads me to believe that I was subject to un-necessary intimidation. I request that you undertake to investigate this matter."

Spadina chokes in North York

North York Council, on a 'fluke' vote, at its July meeting voted to go on record as opposing the southern extension of the Spadina Expressway.

The 6 to 5 vote against the long controversial proposal occurred at 1:10am with eight Pro-Spadina members absent. Because of this, the matter will most certainly be re-opened at a later date. For the time being, the vote has carcrazed Esther "Go-Spadiner" Shiner wondering how she can retain credibility as head of the Go-Spadina group now that her own council won't support the extension.

Voting against the extension were: ReforMetro Aldermen Marilyn Meshberg and Pat 0'Neill plus Controllers Barbara Greene and Ron Summers and Aldermen Milt Berger and Marie Labatte.

LOBBY TO KEEP MERRENS

Roy Merrens is not exactly a household name, but he may be on the way to becoming a cause celebre for reformers.

Merrens, a geography professor at York University, is a harbor commissioner, one of the city's three appointees to the fiveman Toronto Board of Harbor Commissioners (the other two are federal appointments). Merrens is considered to be the spokesman on the TBHC for the public/user viewpoint on matters affecting the waterfront. He has distinguished himself to reformers by his opposition to the STOL port and by his conservationist stance on the future of the

It came as a jolt, therefore, when the city's executive recommended recently that Merrens be replaced on the TBHC by one Robert V. Doty, a man whose corporate pedigree is flawless. Doty's name was put to the executive committee by Fred Beavis and supported by would-be mayor David Smith and once-would-be mayor John Bosley. With David Crombie absent, the only voice of opposition was Art Eggleton.

Doty is by occupation Canadian National Railways' regional manager of governmental and community relations (CN propogandist). He is also chairman of the Planning and Urban Affairs committee of the Metropolitan Board of Trade, and is the board's representative on, and co-chairman of, the City of Toronto's Central Waterfront Planning Committee. The CWPC is currently considering the future development of Toronto's most vital piece of realestate: the railway

lands, in which CN naturally has considerable interest. CN, of course, would like to see some heavy fiscal action on its property. One of Doty's most recent contributions to the debate on the future of the lands was to oppose the creation of a linear park connecting the downtown with Harborfront Park. Doty argued in favor of using the land for "large developments."

Now the city executive wants him as their harbor commissioner in place of Merrens, thus extending Doty's influence on the waterfront even further while at the same time shutting up a voice of criticism.

Fortunately, City Council balked and sent the recommendation back to the executive committee for further consideration. What the committee will do next, only the Board of Trade knows for sure.
